

Extended Family Sponsorship Agreement

2007 Swim Team Season

The Campolindo Homeowners Association allows the Campolindo Cabana Club Marlins swim team to accept team membership applications from swimmers whose families qualify as extended family members of Campolindo homeowners. If you have relatives who live in the general area and whose children would like to be members of the Campolindo swim team, we encourage you to sponsor their application. The Extended Family Sponsorship Agreement form must be included with the swim team registration form by the **April 9 registration deadline**.

If you are a Campolindo homeowner in good standing, you may sponsor for swim team membership a family whose children are related to you in any of the following ways: **grandchildren, nephews and nieces, and the children of your first cousins**. Swim team membership for "extended" families gives access to the Campolindo Cabana Club for scheduled swim team practices, meets and social functions. **Swim team membership does not give non-homeowners general access to the pool facilities**. The regular Campolindo Homeowners Association "guest privileges" conditions apply to the guest swim team member outside official swim team scheduled events. Please visit the CHA web site (www.campo-hoa.org) for details on "guest privileges" policy.

The extended family is responsible for all the obligations that come with swim team family membership for homeowners. However, you as the sponsoring homeowner must agree to also be responsible for your extended family's swim team obligations. In other words, you will do the outstanding meet jobs and bakes if the extended family is unable or unwilling to do them. As an alternative, the sponsoring homeowner or the extended family may provide a \$200 deposit that will be refunded by September 30 if all obligations have been fulfilled.

The Extended Family Sponsorship Agreement form must be signed by both a guest family parent and the sponsoring homeowner, and must accompany the Swim Team Registration Form when submitted to the registrar by the April 9 registration deadline.
