

# Guest Sponsorship Agreement

## 2007 Swim Season

The Campolindo Homeowners Association (CHA) allows the Campolindo Cabana Club Marlins swim team to accept team membership applications under a guest program from swimmers who live in Lamorinda (Lafayette, Moraga, Orinda) and who are not Campolindo homeowners. The CHA charges a non-refundable \$100.00 guest fee per child (maximum \$250 per family) to cover access to the swimming pool during scheduled practices, meets and social events. **Swim team membership does not give non-homeowners general access to the pool facilities.** The regular Campolindo Homeowners Association "guest privileges" conditions apply to the guest swim team member outside official swim team scheduled events. Please visit the CHA web site ([www.campo-hoa.org](http://www.campo-hoa.org)) for details on "guest privileges" policy. A swim team guest membership application must be sponsored by a Campolindo homeowner family, which must also be a registered member of the swim team in the upcoming season. **Each swim team member Campolindo homeowner family may sponsor only one guest family. A guest family may enroll a Mini Marlin only if it has also enrolled a Marlin swimmer.**

Guest membership is valid for a one year period from the registration deadline. A guest member is entitled to hold certain positions on the swim team board, but is not entitled to participate in any general swim team votes relating to policy or by-law amendments. Membership in the Campolindo Cabana Club Marlins swim team is governed by the Campolindo Cabana Club Swim Team By-Laws, which are available at the swim team web site ([www.gocampo.com](http://www.gocampo.com)). Guest memberships are bound by the swim team registration agreement.

Sponsorship requires that either the sponsoring family accept all responsibility for the guest member's meet and job obligations with the same penalty consequences for non-performance as agreed upon for their own membership, or, instead, a \$200 deposit may be made which will be refunded at the end of the season upon satisfactory completion of all obligations as established by the swim team registrar. Registration of a new guest family membership application is subject to availability of space, with priority given to homeowner, guest families from the prior year in good standing, and new extended family applications in that order.

We will accept new guest family applications until the deadline, and process them on a first received basis after the enrollment of homeowner families, homeowner extended families and the prior year's guest families has been tallied. The new guest family will be notified of the outcome as soon as possible before April 13. If not all of the family's swimmers are eligible for enrollment because of the 15 person per gender-age group limit, the family will be given the option to enroll only the eligible children. A decision must be received in writing within 24 hours of notification. **Sponsoring families are responsible for knowing which gender-age groups may exceed the enrollment limit in 2007, and for informing the guest family of the possibility that not all their swimmers may get registered.** You may request that the affected swimmer be placed on a waiting list.

**The Guest Sponsorship Agreement form must be signed by both a guest family parent and the sponsoring homeowner, and must accompany the Swim Team Registration Form when submitted to the registrar by the April 9 registration deadline.**
